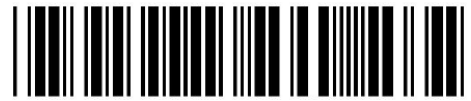

Hazmat Certification - This is to certify that the above-named materials are properly classified, described, packaged, marked and labeled and are in proper conditions for transportation according to the applicable laws and regulations.

Payment of Charges: Accounts over 90 days will be subject to interest charges of 1.5% per month after 30 days plus any collection agency or legal fees necessary for collection of the account. Carrier Liability - Carrier shall be liable for cargo loss and damage in accordance with federal law (49 U.S.C. 14706) with respect to all shipments. Carrier shall not be liable for special or consequential damages. Limitation of Liability/Declared Value - Carrier's Liability for cargo loss and damage shall be limited to the shipper's actual cost of the articles, lost, damaged or destroyed and shall not exceed \$0.50 per pound or \$50,000 per truck load (whichever is less) unless shipper requests a higher Declared Value in the space below and agrees to pay Carrier \$0.65 for each additional \$100.00 of declared value.
